This audit must include a general inventory of the property, an estimate of its performance and work proposals aimed at upgrading the property to class C. This observation must be accompanied by an estimate of energy savings and that of the amount of work to be carried out and the impact of this on the energy bill. Decree No. 2022-780 of May 4, 2022.
